If you already hold a master's degree and are pursuing certification as a **Board-Certified Behavior Analyst®** (BCBA®), Kean University's **ABA Post-Master's program** fulfills the **coursework requirement** set by the **Behavior Analyst Certification Board** (BACB): 315 hours of graduate-level instruction under **Pathway 2**, aligned with the **2027 exam standards**.

This program includes **seven courses** specifically designed to meet BACB's Pathway 2 coursework requirements. Take as many or as little courses per semester that fits your schedule. However, it is jnot recommended to take ore than two classes if working full time. To be eligible to sit for the BCBA® exam, applicants must also complete **supervised fieldwork** as defined by the BACB. It is strongly recommended that you verify whether your existing master's degree meets current BACB eligibility requirements by visiting www.BACB.com.

To practice ABA in New Jersey, you must also meet **state licensure requirements**, which include holding **BCBA® certification**.

Admission Requirements

In addition to the University's admissions requirements:

- A Master's Degree in an acceptable field of study (Accepted by BACB if you plan to sit for the BCBA exam) from a qualifying institution 3.0 cumulative grade point average
- Official transcripts from all institutions attended
- Three letters of recommendation (professional experience)
- Furnish an appropriate scholarly writing sample
- Professional Resume/CV
- Professional statement of interest
- Official TOEFL or IELTS score reports (International Students ONLY)
