SUBJECT:	UPC Recommendations for the 2018 Quality First Initiatives
DATE:	May 7, 2018

The University Planning Council reviewed 19 QFI proposals submitted by faculty and staff of the Kean University community. The proposals were posted on a Google Drive for UPC membership review, and we used the Campus Labs platform to anonymously rate each proposal using the following rating scale: Do Not Recommend Support; Low Priority for Support, Moderate Priority for Support, and High Priority for Support.

The first report (attached) presents the proposals in the order in which they were received by the UPC. Also included is the amount requested and the weighted mean for each request, which is calculated using the numeric values of 0 for a "Do Not Recommend Support" response; 1 for a "Low Priority for Support" response, 2 for a "Moderate Priority for Support" response, and 3 for a "High Priority for Support" response. The highest possible mean value would be a 3.00 (that is, if everyone evaluated the proposal as high priority for support). You will see that weighted mean values vary from a high of 2.67 to a low of 0.21.

The second report sorts the results in priority order based upon the weighted means. Thus, the proposal for "Connecting the Digital Student to the Virtual Learning Commons" appears first on the report since it received the highest priority rating.

Please note that the seven proposals with the highest ratings would tally to a total funding of \$204,402.77. The amount of funding you made available for QFI 2018 was \$250,000.00. I hope that you will also consider partial funding for the proposals, "Human Rights Learning Community" and "Supporting Veterans Transitioning through the Use of CAD and CAM" both of which received high rankings.

All QFI proposals are included in the packet for your consideration.
